1 Introduction

Do not use abbreviations in the title. All papers must be submitted electronically in pdf format. The paper should be no more than four pages long. The paper should include the following sections: introduction, methods, results and conclusions. Each of them can have more than one sub- or subsub- sections.

In formatting your page, set left, top, and right margins to 19.1 mm and bottom margin to 25.4 mm. Use a two-column format. Left and right-justify your columns. Use automatic hyphenation and check spelling.

2 Methods

Type sizes and typefaces to use are listed in Table 1. Briefly, abstract heading font is Times, 11pt, bold. Abstract text font is Helvetica, 10pt, italic. Keywords heading font is Times, 11pt, while the keywords font is Helvetica, 10pt, bold. Text font is Times 10pt. Headings font is Times, 12pt, bold. Title font is Times, 14pt, bold. Author names and affiliations font is Helvetica 12pt.

3.1 Tables and figures




Figure 1: Example of figure.

Tables and figures can fit across both columns if

necessary. Captions go beneath tables and figures. Large figures and tables may span across both columns. Avoid placing figures and tables before their first mention in the text. Use the abbreviation "Fig." even at the beginning of a sentence. An example of figure is given in Fig. 1.

3.2 References

Citations should appear in the text, in square brackets, and in their order of appearance [1]. The sentence punctuation follows the bracket [2]. Refer simply to the reference number, as in [3]. Capitalize only the first word in a paper title, except for proper nouns and element symbols. References font is Times, 10pt.

3.3 Abbreviations and Acronyms

Define abbreviations and acronyms the first time they are used in the text, even after they have already been defined in the abstract. Abbreviations that incorporate periods should not have spaces: write ‘C.N.R.S.’, not ‘C. N. R. S.’.

3.4 Equations

Number equations consecutively with equation numbers in parentheses flush with the right margin, as in Eq.1. Use parentheses to avoid ambiguities in denominators. Punctuate equations with commas or periods when they are part of a sentence, as in Eq.1. An example of equation is given in the following:

$$A + B = C, \quad (1)$$
